- viii) The relevant aquaculture area is under the supervision of the competent authority and is monitored for relevant diseases according to the relevant standards of the OIE Aquatic Animal Health Code. There has been no outbreak report of OIE listed diseases;
- ix) Clinical signs of animal diseases or parasitic diseases have not been found during routine examination.

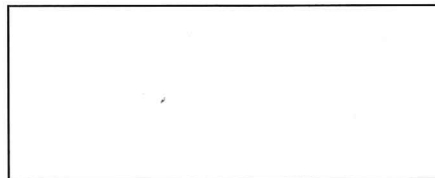
