

## Food Safety 食品安全

## Food safety is the CFIA's top priority 保障食品安全性乃CFIA的首要任務

➤ CFIA regulates food that is sold domestically, imported into Canada, and exported from Canada CFIA對加拿大境內產銷、進出口食品皆立法規範

## Context 相關內容

> Protecting the public from foodborne illnesses is a key food safety objective

保護民眾遠離食材帶來的疾病乃食品安全一重要目標

Fundamental to this protection is assuring food products comply with regulatory requirements

確保食品遵守相關規範為達成此目標之根本辦法

- > Countries implement processes to assure compliance 各國應採行相對措施以確保遵守相關規範
  - Domestic food safety programs include 境內食品安全計畫包括:
    - ✓ Product evaluation 產品評估
    - ✓ Facility inspection and/or 設備檢驗 和/或
    - ✓ Process assessment 生產過程稽核
  - Imported food safety programs include 進口食品安全計畫包括:
    - ✓ Border inspections 邊境查驗
    - ✓ Importer controls 進口商監管
    - ✓ Foreign facility inspections 外國工廠查驗





# Challenges 面臨的挑戰



- ➤ Canadians consume significant amounts of imported food 加拿大人對進口食品的消費為數可觀
- ➤ Numerous products manufactured in Canada include ingredients from other countries 為數眾多的加拿大製品內含境外原料
- ➤ Consumers expect safe food and demand greater access to food safety information 消費者極為重視食品的安全性且對於食品安全資訊的需求極為強勁

## Import Control Tools 進口控管手段

> Governments can use a variety of approaches within an import control program:

#### 政府可在單一控管計畫中採行多元政策:

- To assess compliance of products and importers 評量產品及進口商是否遵守規範
- To monitor effectiveness of import program 監視進口控管計畫是否有效執行

#### > Approaches can be 可採行政策有:

 Controls in the importing country, e.g., monitoring and intervention at the border

控管進口國家,例:在邊境實施監控及有效介入

 Controls in the exporting country, e.g., equivalence, comparability/systems recognition

控管出口國家,例:在雙方對等及實力/體制均等下的相互承認

 Importer-based controls, e.g., importer licensing, product testing and certification

控管進口商,例:進口執照、產品測試及認證






## **Border Controls: Information is Key**

## 邊境監管:情報是關鍵

- ➤Ongoing scanning of new and emerging risks 持續對新興或可能爆發的風險做掃描偵測
  - Food borne illnesses or outbreaks in foreign countries 在其他國家因食材感染所爆發的問題
  - Other contaminants and risks 其他污染物和風險
- ➤ Collaboration and communication with trading partners 與貿易夥伴的合作及溝通
  - Notification of issues of concern 對具重大影響之事件的通報
  - Clarification of enhanced strategies 對重點加強策略之清楚說明
- Border blitzes and look outs
  - 邊境之巡緝行動與展望
  - 將未達規範之產品被引進國內的可能性降至最低 Minimise notantial for import of non compliant produc

#### **Border Controls: Import Notification**

#### 邊境監管:進口通報

➤ Knowledge of products being imported, by whom, and when – basic requirement for evidence-based import programs

對進口物的瞭解,如引渡者及時間——實證進口作業之基本要求

- Regulatory requirements for import notification 進口通報控管要求
  - ✓ Meat: pre-import notification 肉類:進口前通報
  - ✓ Fish: notification on importation (within 48 hours) but product detained at importer warehouse (no movement) 魚類:進口時通報 (48小時內) 且貨品須置於進口商倉庫內(禁止搬動)
  - ✓ Electronic data exchange from Customs and Border Services for other products 其他貨品:海關與邊境服務機關間將以電子通訊方式交換訊息
- Program design 計畫設計
  - ✓ Ensures product is available for inspection 確保有貨品可接受查驗
  - ✓ Can target high risk commodities, importers with history of non compliance 可鎖定高風險的農產品及有未遵守規範之前科的進口商
  - ✓ 5% random monitoring of products to assess compliance trends and program effectiveness 對5%的貨品抽樣查驗以評量規範的走向及計畫之功效





## **Increased Assurances of Food Safety**

## 食品安全性的保障提升

- ▶In addition to border controls, importing countries are seeking more effective means of assuring imported food safety 除了邊境控管以外,進口國間也持續尋找有效方法以確保食品安全性
- ➤ Use of import controls:

進口控管的實際執行:

- Importers 進口商
  - ✓ Importer licensing, with 進口執照,且須符合
  - ✓ Supplier quality assurance 供應者品保之規範
- Governments 政府
  - ✓ Arrangements to recognise foreign food safety systems 訂定識別外國食品安全機制的準備計畫
  - ✓ MOUs/MRAs/Product certificates MOUs/MRAs/產品 認證



## Exporting Country Controls 出口國控管

➤ Work with foreign governments to provide assurances of food safety

與外國政府合作以保障食品安全性

Assurances can include:

保障內容包括:

- Recognition of foreign food safety systems, e.g. equivalence determinations, arrangements 認識外國食品安全性機制,例:對等的定義解釋、配套措施
- Lot by lot or establishment certification 逐批處理或建立認證機制
- Information exchange and collaboration 資訊情報相互交流與合作





## Importer Controls 進口商控管

- ▶ Importer Quality Management Licence 進口商的品質管理證照
  - Licence holder must develop and submit a written plan that meets the reference standard which includes:

持照者須建立並繳交一份符合相關標準的書面計畫,其內容包括:

- ✓ License holder responsibilities; Product sourcing plan; Product safety assessment and management plan; Verification and maintenance of the QMPI plan; Record and document control 持照者應負責任;貨品來源計畫;貨品安全性檢驗及管理計畫;QMPI計畫之驗證與維護;紀錄與文件的控管
- Licence conditions may include a Supplier Quality Agreement with the following elements:

證照所附條件包含一份供應者品質保證協議,其要項如下:

- ✓ A process for determining supplier's suitability as an SQA supplier 一套決議供應商是否符合SQA供應者的處理程序
- ✓ A process for maintaining records and documents associated with the SQA agreement
  - 一套維護SQA協議相關紀錄與文件的處理程序
- ✓ Procedures to verify the implementation and effectiveness of the SQA 一套驗證SQA是否落實及其功效之執行步驟
- Annual audit against the plan to maintain licence 通過書面計畫的年度稽核以持續保有證照

## New Regulatory Proposal for Imported Foods 管制進口食品的新提案

➤ The CFIA is proposing a new regulation for the non federally registered sector (NFRS) that includes:

CFIA正對非官方登記部門(NFRS)提出一項新法案,其包括:

- General provisions for importers 針對進口商之一般條款
  - ✓ Safety provisions for imported foods 進口食品安全條款
  - ✓ Notification of unsafe food不安全食品之通報
  - ✓ Recall plan 食品主動回收計畫
  - ✓ Maintenance of records of imported products, distribution and complaints 詳載食品進口、物流及消費者申訴記錄
- Provisions for licensing importers

針對持照商之條款

- ✓ Importers will be expected to have a written and implemented preventive food safety control system 進口商將必須提供一份已實施的預防性之食品安全管制系統書面計畫



## **Enhanced Import Controls will...**

## 強化進口控管將能夠...

► Enhance compliance of products with Canadian regulatory requirements 加強各產品遵守加拿大的管制要求

- Importers will have an increased understanding of their accountability with respect to the safety and proper labelling of the products that they import into Canada 進口商將更加瞭解他們對進口至加拿大的貨品之安全性以及正確標識的應負責任
- ➤ Support inspection and monitoring programs that verify compliance with food safety requirements 幫助檢驗與監控機制驗證食品是否符合安全性要求

## Conclusion 結論

- ►Imported food programs 進口食物系統計畫
  - Provide assurances that imported foods meet Canadian requirements 保障進口食物符合加拿大規定
    - ✓ Hold importers responsible for products they import 使進口商對其引進的貨品負責
    - ✓ Governments maintain responsibility for oversight 政府將善盡監督責任
  - Key parameters 關鍵因素
    - ✓ Efficient use of resources 是否有效地利用資源
    - ✓ Risk based, evidence-based 風險評估、實證管理
