**IV. HEALTH ATTESTATION**

I, the undersigned, hereby certify that:

- The above mentioned product complies with the requirements laid down in OIE regulations concerning restrictive measures of the following diseases notifiable to the OIE and transmissible to the given species in accordance with EC and national disease eradication legislation: foot and mouth disease, vesicular stomatitis, Rinderpest, peste des petits ruminants, contagious bovine pleuropneumonia, Lumpy skin disease, Rift valley fever, sheep- and goat pox;
- The area within a radius of 10 kms from the place of export of the above mentioned product, has been free from foot and mouth disease, vesicular stomatitis, Rinderpest, peste des petits ruminants, contagious bovine pleuropneumonia, lumpy skin disease, Rift Valley fever, sheep and goat pox, during the last 30 days;
- No case of foot- and- mouth disease has occurred in the Netherlands during the last 6 (six) months;
- The manufacturing plant is approved by the competent authority of the exporting country or an other EU member state;
- The agent causing Bovine Spongiform Encephalopathy (BSE) has never been detected in milk and there is no scientific doubt about the absence of BSE in milk and therefore the mentioned product(s) is/are regarded as free of BSE and in this respect completely safe for human consumption;
- The milk or milk ingredient of which this product is made has been heated at a temperature of not less than 72 °C for at least 15 seconds (or a treatment with at least an equivalent effect) in order to avoid the presence of vegetative pathogenic micro-organisms;
- The product is fit for human consumption;
- That the product has been packed in new containers;
- The manufacturing processes as well as the resulting products are under regular control of the

competent authorities for the hygienic and bacteriological requirements, including the control on the presence of Salmonella and other pathogenic micro-organisms associated with milk, based on Regulation (EC) No 852/2004;

10. Precautions have been taken to avoid (re)contamination of the product during manufacturing, processing, transportation and storage with pathogenic agents and cross-contamination in accordance with EU and national legislation.
