<b>Part II Details concerning health</b>	<p>By signing, the veterinarian officer confirms the following:</p> <ul style="list-style-type: none"> <li>- The establishment manufacturing the above products has a food safety management system based on HACCP principles and is regularly audited by the competent enforcement authorities.</li> <li>- All products and their ingredients must be manufactured in accordance with the legal requirements applying in Switzerland.</li> <li>- The products must not contain any substances whose nature or quantity, according to current knowledge, could endanger human health.</li> <li>- The manufacturing plant is approved by the competent authority of the exporting country. The product was not contaminated by pathogens of animal contagious disease in raw material, during manufacturing, processing, transportation and storage.</li> <li>- For dairy products derived from sheep or goats, no outbreak of Peste des petits ruminants (PPR) has occurred for at least 21 days in the exporting country prior to export.</li> <li>- For dairy products derived from cattle, no outbreak of lumpy skin disease (LSD) has occurred for at least 90 days in the exporting country prior to export.</li> </ul>
