# Kroger Expands Recall of 12 oz. packages of Simple Truth Dry Roasted Macadamia Nuts because of Possible Health Risk

The Kroger Co. (NYSE: KR) today announced it has expanded the recall of its 12 oz. packages of Simple Truth Dry Roasted Macadamia Nuts due to potential *Listeria monocytogenes* contamination. Listeria monocytogenes is an organism which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Although healthy individuals may suffer only short-term symptoms such as high fever, severe headache, stiffness, nausea, abdominal pain and diarrhea, Listeria infection can cause miscarriages and stillbirths among pregnant women. No customer illnesses have been reported to date.

In May, we were informed by the supplier that the macadamia nuts used in this product may have the potential to be contaminated with *Listeria monocytogenes*. Routine sampling of a different item produced by the supplier for another company revealed positive *Listeria monocytogenes* results, and a subsequent investigation of the manufacturing environment discovered a contaminated piece of equipment.

The product comes in a 12 oz., clear plastic package marked with expiration dates of: Dec. 09, 2017, Mar. 02, 2018, Mar. 03, 2018, or Apr. 07, 2018 stamped on the side. **Product was distributed between 12/9/2016 to 6/13/2017.** Kroger has removed the following item from store shelves and initiated its customer recall

notification system that alerts customers who may have purchased recalled products through register receipt tape messages and phone calls.

Customers who have purchased any of the products described above should not consume them and should return them to a store for a full refund or replacement.
